- Motorland Fest 4
 - New format of Super Laps on Saturday, Super Cup on Sunday—good feedback

 - A. Sanford pointed out that drivers can participate in as many days as desired (Test and Tune on Friday, Super Lap on Saturday, Super Cup on Sunday)
